Letter From the President

Mark your calendars for February 19, as we join with a number of other Engineering organizations for the annual Engineer's Week Luncheon. It will be held in the Hilton Hotel at Polaris and the speaker will be the National Executive Director for Engineer's Without Borders. As always, it should be a great event as many of us come together to celebrate being in the engineering industry.

As we start this New Year there are many activities that both the Central Ohio Section and National ASCE will be participating in, many of which revolve around infrastructure. The aging infrastructure is now getting the National press it deserves and ASCE has been actively involved in the discussion. National has recently posted "Principles for Infrastructure Stimulus Investment," which are the guidelines they are presenting to Congress and President Obama's staff. I invite you to review the fundamental criteria



and the guidelines they are proposing. In addition to the guidelines, National sent out on January 28th the early release of the Nations Infrastructure Report Card. ASCE assigned a D grade to the state of our Nation's infrastructure and an estimated \$2.2 trillion in repairs needed. The early release was due to the stimulus package that is being considered by President Obama's administration. This is hitting the streets at a good time and will hopefully get the media attention it deserves. The detailed information on the report card and the grades for the individual categories can be found on the asce.org website.

In addition, there are members of the Central Ohio Section contributing to the State of Ohio ASCE Infrastructure Report Card that Ohio Council has been championing. They are still in need of volunteers and Kevin Carpenter is the main contact to reach if you are interested. Please email him at Kevin.Carpenter@WDPartners.com if you have interest in helping out. The State of Ohio report card will be a valuable tool to communicate with public officials in getting the word out on our state infrastructure needs. Ohio Council plans to unveil this document at a media event at the Statehouse this May.



In the month of March we have several events as we close out winter. The luncheon will be on March 19th and we will be having a discussion on the OSU Medical Center master plan. Also, on March 12th we will have our annual spring technical seminar at the Department of Agriculture building. This all day event is on the Leadership in Energy and Environmental Design (LEED) process, which is a hot topic these days. This seminar is designed to give you general and detailed background in order to prepare for the LEED AP examination. 2009 Central Ohio Section Technical Seminar


