Topic: Scioto Mile Promenade and Park

Currently under construction, the \$44 million Scioto Mile project will certainly re-shape the downtown landscape. The project extends along Civic Center Drive from Broad Street to Main Street and consists of two major parts: The Promenade and The John W. Galbreath Bicentennial Park. Within these parts, there is extensive roadwork and traffic reconfiguration, restoration of an 80-year-old sewer, landscaped pedestrian pathways, over 15,000 SF of fountains, two post-tensioned structures, and a Prow extending into the river at the former Town Street bridge abutment. Join Jeff and Jon as they give an overview of the Scioto Mile proejct, including a 3D tour of sights unseen.

## OSU College of Engineering Lichtenstein Distinguished Lecture

The first Lichtenstein Distinguished Lecture of the academic year will be presented by Dr. John M. Kulicki, Chairman and CEO, Modjeski and Masters, Inc. Dr. Kulicki has over 35 years of experience in virtually all aspects of bridge analysis and design, and led a 50-member team of experts to develop the AASHTO LRFD Bridge Design Specifications. Dr. Kulicki is also the author of AASHTO's "Guide Specifications for Load Factor Design of Trusses."

The lecture, "A Tale of Bridge Engineering and Public Process or The Unstoppable Force and the Immovable Object" is a case study that will address the factors – natural, engineering, aesthetic, economic, societal, and political - of a design concept for a bridge that would be the longest cable stayed bridge in the Western Hemisphere, and the widest in the world. The presentation will also review other Modjeski and Masters, Inc. designs for which factors – other than engineering efficiency – were major contributors to the final design. Mr. Kulicki will also offer a few observations on the increasing use of highly computerized design processes.

The event will take place on Friday, October 16, at 3:30 P.M in Room 410 Hitchcock Hall, 2070 Neil Avenue at the Ohio State University. Contact Hojjat Adeli at 614-292-7929 for additional information. The lectures are free and the attendees will receive one hour of PDH for each lecture.



### **Elected Governor Nominations**

To be considered, the nominee must have served as a Section or Branch officer OR as a member of a Section or Branch committee OR as a member of a national committee of the Society. Additionally, a Governor "should have professional credibility with leadership skills, management experience, and significant career accomplishments; should be a confident communicator and presenter, a visionary planner, and a motivator; and possess the ability to work in teams, be a negotiator, conflict manager and consensus builder. " Governors shall also have "skills in communicating with members and the public, in government relations and advocacy, and in conducting events that will engage and serve members."
